Foreword

Directive 2007/2/EC of the European Parliament and of the Council [INS DIR], adopted on 14 March 2007 aims at establishing an Infrastructure for Spatial Information in the European Community (INSPIRE) for environmental policies, or policies and activities that have an impact on the environment. INSPIRE will make available relevant, harmonised and quality geographic information to support the formulation, implementation, monitoring and evaluation of policies and activities, which have a direct or indirect impact on the environment.

INSPIRE is based on the infrastructures for spatial information established and operated by the 28 Member States of the European Union. The Directive addresses 34 spatial data themes needed for environmental applications, with key components specified through technical implementing rules. This makes INSPIRE a unique example of a legislative "regional" approach.

To ensure that the spatial data infrastructures of the Member States are compatible and usable in a Community and trans-boundary context, the Directive requires that common Implementing Rules (IR) are adopted in the following areas.

- Metadata;
- The interoperability and harmonisation of spatial data and services for selected themes (as described in Annexes I, II, III of the Directive);
- Network Services;
- Measures on sharing spatial data and services;
- Co-ordination and monitoring measures.

The Implementing Rules are adopted as Commission Decisions or Regulations, and are binding in their entirety.

In particular with respect the Network Services, Implementing Rules are required for the following services (Article 11(1) of the Directive):

- a) discovery services search for spatial datasets and spatial data services on the basis of the content of corresponding metadata, and display the metadata content;
- b) view services as a minimum, display, navigate, zoom in/out, pan, or overlay spatial datasets and display legend information and any relevant content of metadata;
- c) download services enabling copies of complete spatial datasets, or of parts of such sets, to be downloaded;
- d) transformation services enabling spatial datasets to be transformed with a view to achieving interoperability;
- e) invoke spatial data services "enabling data services to be invoked."

The Implementing Rules are adopted as Commission Decisions or Regulations, and are legally binding.




Figure 1 - relationship between the INSPIRE Implementing Rules and the associated Technical Guidance.

In addition to the Implementing Rules, non-binding Technical Guidance documents describe detailed implementation aspects and relations with existing standards, technologies and practices in order to support the technical implementation process. They may need to be revised during the course of implementing the infrastructure to take into account the evolution of technology, new requirements, and cost benefit considerations. In other words, these Technical Guidance documents are supporting material to assist in the technical implementation of the INSPIRE Directive but no additional obligations can be derived from these documents over and above the obligations set out in the Directive and the Implementing Rules. The Technical Guidance documents are also not intended to interpret legal obligations. Figure 1 illustrates the relationship between the INSPIRE Regulations containing Implementing Rules and their corresponding Technical Guidance documents.

This Technical Guidance relates to the INSPIRE Spatial Data Services and services allowing spatial data services to be invoked.

Implementing this Technical Guidance are designed to maximise the interoperability of INSPIRE services. Technical Guidance documents describe how Member States might implement the

Implementing Rules described in a Commission Regulation. The technical provisions and the underlying concepts are often illustrated by use case diagrams and accompanied by examples. Technical Guidance documents may also include non-binding technical recommendations that should be satisfied if a Member State chooses to conform to the Technical Guidance. However, these recommendations have no legally binding effect.

1 Introduction

1.1 The INSPIRE Directive and Implementing Rules

Directive 2007/2/EC of the European Parliament and of the Council of 14 March 2007 establishing an Infrastructure for Spatial Information in the European Community (INSPIRE) was published in the official Journal on the 25th April 2007. The INSPIRE Directive entered into force on the 15th May 2007.

The purpose of the infrastructure is to enable the formulation, implementation, monitoring activities and evaluation of Community environmental policies at all levels – European, national and local – and to provide public information.

INSPIRE builds on the infrastructures for spatial information that have already been created by the Member States. The components of those infrastructures include: metadata, spatial data themes (as described in Annexes I, II, III of the Directive), network services and technologies; agreements on data sharing, access and use; coordination and monitoring mechanisms, processes and procedures.

The guiding principles of INSPIRE are:

- that the infrastructures for spatial information in the Member States should be designed to ensure that spatial data are stored, made available and maintained at the most appropriate level;
- that it is possible to combine spatial data from different sources across the Community in a consistent way and share them between several users and applications;
- that it is possible for spatial data collected at one level of public authority to be shared between all the different levels of public authorities;
- that spatial data are made available under conditions that do not restrict their extensive use; and,
- that it is easy to discover available spatial data, to evaluate their fitness for purpose and to know the conditions applicable to their use.

The text of the INSPIRE Directive is available from the European Union Law website (EU-LEX) <u>http://eur-lex.europa.eu/LexUriServ/LexUriServ.do?uri=CELEX:32007L0002:EN:NOT</u>. The Directive identifies what needs to be achieved, and Member States have two years from the date of adoption to bring into force national legislation, regulations, and administrative procedures that define how the agreed objectives will be met taking into account the specific situation of each Member State. To ensure that the spatial data infrastructures of the Member States are compatible and usable in a Community and trans-boundary context, the Directive requires that common Implementing Rules (IR) are adopted in a number of specific areas. Implementing Rules are adopted as Commission Decisions, and are binding in their entirety.

According to Article 5(4) of the Directive, the INSPIRE Implementing Rules shall take account of relevant, existing international standards and user requirements.

1.2 Technical Guidance for INSPIRE Spatial Data Services and services allowing spatial data services to be invoked

The scope of this document is to detail the INSPIRE technical requirements for **Spatial Data Services** and services allowing spatial data services to be invoked from the Implementing Rules, such that these services can be described and implemented consistently across Europe.

These Implementing Rules are, as much as possible, in conformance with European and international standards, current practices in stakeholder communities and relevant European initiatives such as e-Government, and the EU interoperability framework.

3 Terms and abbreviations

3.1 Terms

- (1) **Access point**: an internet address containing a detailed description of a spatial data service, including a list of endpoints to allow its execution.
- (2) **End point:** the Internet address used to directly call an operation provided by a spatial data service.
- (3) **Spatial data services** means the operations which may be performed, by invoking a computer application, on the spatial data contained in spatial data sets or on the related metadata [**INS DIR**, Art. 3].
- (4) **Network services** are services provided for in Article 11(1) of **[INS DIR]** for the discovery, viewing, download and transformation of spatial data sets and services. The services shall be conformant regarding the specific requirements in Commission Regulation (EC) 976/2009.

NOTE In **[INS DIR**, Art. 11] also a 5th type of network service is defined: "services allowing spatial data services to be invoked". Since all services can be invoked when metadata is published and accessed through a discovery service, there is no need to have a special service to invoke other services. Instead, in practice, the discovery service will take the role as making it possible to invoke a service. (see also section 4.2.2).

- (5) **Discovery service** is a service that makes it possible to search for spatial data sets and services on the basis of the content of the corresponding metadata and to display the content of the metadata [**INS DIR**, Art. 11].
- (6) **View service** is a service making it possible, as a minimum, to display, navigate, zoom in/out, pan, or overlay viewable spatial data sets and to display legend information and any relevant content of metadata [**INS DIR**, Art. 11].
- (7) **Download service** is a service enabling copies of spatial data sets, or parts of such sets, to be downloaded and, where practicable, accessed directly [**INS DIR**, Art. 11].
- (8) **Transformation service** is a service enabling spatial data sets to be transformed with a view to achieving interoperability [**INS DIR**, Art. 11].
- (9) Invocable spatial data service is a spatial data service that fulfils all of the following: (a) has metadata which fulfils the requirements of Commission Regulation (EC) 1205/2008, (b) has at least one resource locator that is an access point, (c) is conformant with a documented and publicly available set of technical specifications providing the information necessary for its execution. [INS ISDSS, Art. 2.33]

NOTE The technical specifications could e.g. be a web site documentation explaining how to use the service, or they could be more formal, e.g. a WSDL document or a description of a RESTful interface.

- (10) **Interoperable spatial data service** means an invocable spatial data service which fulfils the requirements of Annex VI of [**INS ISDSS**]. [**INS ISDSS**, Art. 2.34]
- (11) **Harmonised spatial data service** means an interoperable spatial data service which fulfils the requirements of Annex VII of [**INS ISDSS**]. [**INS ISDSS**, Art. 2.35]
- (12) **Conformant spatial data set** means a spatial data set in conformity with Commission Regulation (EU) No 1089/2010. [**INS ISDSS**, Art. 2.36]

- (13) **Interface:** named set of operations that characterise the behaviour of an entity as defined by ISO 19119:2005. [**INS ISDSS**, Art. 2.38]
- (14) **Operation:** means an action supported by a spatial data service. [INS ISDSS, Art. 2.37]
- (15) **Resource locator:** The resource locator defines the link(s) to the resource and/or the link to additional information about the resource. The value domain of this metadata element is a character string, commonly expressed as uniform resource locator (URL). [**INS MD**, Annex, Part B 1.4].

4 Technical Guidance

This section includes guidance related to categories of SDS (section 4.1), requirements from the different INSPIRE Implementing Rules and the Directive (section 4.2) and instructions on meeting the requirements for SDS included in [**INS ISDSS**] (sections 4.3 to 4.5) and for services allowing SDS to be invoked (section 4.6).

The technical guidance for the requirements included in **[INS ISDSS]** are structured according to conformance classes. The conformance classes for invocable SDS (section 4.3) and interoperable SDS (section 4.4) include only requirements on the creation of additional metadata. The conformance class for harmonised SDS includes requirements related to metadata, quality of service, output encoding and the Get Harmonised Spatial Data Service Metadata Operation.

4.1 Categories of INSPIRE Spatial Data Services

The spatial data services covered by the INSPIRE Directive are defined in Art. 4(3) as follows:

"This Directive shall also cover the spatial data services relating to the data contained in the spatial data sets referred to in paragraph 1."

This means, the Directive covers all SDS that relate to INSPIRE-relevant data as defined in Art. 4(1) of [**INS DIR**]. In addition, an SDS could also include other data.

According to Art. 5(1) of [**INS DIR**], all SDSs within INSPIRE shall be described with metadata in conformity with [**INS MD**]. Furthermore, all SDS shall meet the requirements for data and service sharing laid down in Art. 17 of [**INS DIR**].

The SDSs that Member States establish and operate according to Art. 11 of **[INS DIR]** are called *network services*. All network services shall meet the requirements specified in **[INS NS]**.

Those SDS that are not network services, but fulfil the requirements of Commission Regulation (EC) 1205/2008, have at least one resource locator and follow a publicly available technical specification are called *invocable spatial data services*. All invocable SDS shall meet the requirements specified in [**INS ISDSS**]. All other SDS are referred to in this document as *other SDS*.




Figure 2: Guidance to understand if a spatial data services is in or out of scope of INSPIRE⁵

The flowchart in Figure 2 provides guidance for distinguishing services that are not within the scope of INSPIRE, network services, invocable SDS and other SDS.

SDS regulated by [INS ISDSS] are further divided into three different categories depending on level of interoperability: Invocable SDS, Interoperable SDS and Harmonised SDS. SDS regulated by [INS NS] consist of four different types of services: discovery services, view services, download services and transformation services.




Figure 3 - Spatial data services in the context of INSPIRE and their relationships to different types and categories of services. * Discovery Services also take the role as making it possible to invoke a service.

Figure 3 gives an overview of the different types of spatial data services.

4.2 Requirements according to INSPIRE regulations

4.2.1 Requirements for Spatial Data Services

For the spatial data sets and services for which metadata have been created, member states shall establish and operate at least one (but may decide to establish and operate more than one) of each type of network service defined in **[INS DIR**, Art. 11] for discovery, view, download and, if necessary, transformation.

Transformation services are not mandatory to implement as long as "spatial data sets are made available in conformity with the implementing rules [for data interoperability] through the adaptation of existing spatial data sets" [**INS DIR**, Art. 7(3)], i.e. if they are transformed into the INSPIRE data models through some other means (e.g. offline transformation or on-the-fly transformation in the download service).

These services shall follow the requirements of [INS NS].

All spatial data services, including network services, shall have metadata according to [**INS MD**]. Furthermore, Member States need to adopt measures for data sharing for all spatial data services according to [**INS DIR**, Art. 17].

Invocable spatial data services, which have a technical specification providing information necessary for its execution (e.g. an API description), shall also have additional metadata as described in Annex V and VI and, where practicable, meet the requirements related to metadata, quality of service, output encoding and the Get Harmonised Spatial Data Service Metadata Operation that are described in Annex VII of [**INS ISDSS**].

NOTE 1 These additional requirements do not have to be met by, and are not relevant to, network services, as clarified by **[INS ISDSS**] ("This Regulation does not apply to the network services falling within the scope of Commission Regulation (EC) 976/2009").




Figure 4 - Metadata required for SDS

The requirements related to metadata are illustrated in Figure 4.

4.2.2 Requirements for services allowing spatial data services to be invoked

No specific Implementing Rules exist in INSPIRE that specify requirements for "services allowing spatial data services to be invoked" as defined in [**INS DIR**, Art. 11(1.e)].

However, in the latest amendment of **[INS NS]** (Commission Regulation (EU) No 1311/2014 of 10 December 2014), the definition of "INSPIRE metadata element" is extended beyond the metadata elements defined in **[INS MD]** to include also the metadata elements defined in Annexes V-VII of **[INS ISDSS**].

This means that discovery network services need to provide access also to the additional SDS metadata elements, which contain, among other things, information necessary for the invocation of SDS. Through the provision of these metadata additional elements, the obligation to provide (network) "services allowing spatial data services to be invoked" is being fulfilled.

4.2.3 Guiding flow chart




Figure 5 - Flow chart illustrating the obligations for spatial data services

In the INSPIRE scope it is required to set up Network services to be able to discover, view, download and, if necessary, transform data that is described in [INS DIR, Annexes I-III]. Specific regulations are published for setting up these services. But since other spatial data services can be of broad variation there is no detailed description. To support the understanding of SDS and its requirements the flow chart in Figure 5 can be used.

At the starting point there is an already existing service. It could be a service that was not initially intended as an INSPIRE service when it was set up.

Guidelines for implementing the requirements on metadata for harmonised SDS are provided in **[INS MD TG]**. This document only provides implementation guidance for the requirements on quality of service, output encoding and the Get Harmonised Spatial Data Service Metadata Operation.

4.5.1 Quality of the Harmonised Spatial Data Service

[**INS ISDSS**] requires that the probability of a harmonised spatial data service to be available shall be 98 % of the time.

4.5.1.1 Normalized testing procedure

The following procedure has been copied from [INS NS TG].

TG Requirement 2Availability shall be measured consistently based on sample reference
requests to a given service. Minimum 10 reference requests per hour shall be
issued to the service continuously during its lifetime.To respect long running operations, the number of requests may be reduced.
In such cases, a new request can be issued maximum 6 minutes after the

EXAMPLE If a previous request for a 1 GB data set was issued at 8:00 and lasts until 8:30, the next reference request shall be issued at the latest at 8:36.

4.5.2 Encoding of the spatial objects in the Spatial Data Service

[INS ISDSS] requires a harmonised spatial data service returning spatial objects in the scope of the [INS DIR] to encode those spatial objects according to [INS ISDSS].

Article 7 of [**INS ISDSS**] on Encoding requires the following:

- 2. Every encoding rule used to encode spatial data shall be made available.

The INSPIRE data specifications Technical Guidelines contain default encoding rules for all spatial data themes that meet the requirements of [**INS ISDSS**].

4.5.3 Operations for Harmonised Spatial Data Services

[**INS ISDSS**] requires a harmonised spatial data service to include a Get Harmonised Spatial Data Service Metadata operation, as specified in the following sections.

NOTE The mapping of the Get Harmonised Spatial Data Service Metadata response to an extended capabilities document works well for OGC web services, which already offer a GetCapabilities operation. 4.5.3.2 Scenario 1 – Get Capabilities response – Metadata URL

In this scenario, in order to avoid duplication of metadata already provided in the ISO metadata, the capabilities document returned by the Get Harmonised Spatial Data Service Metadata operation has only to provide the reference to the ISO metadata and to a document that describes all the operation provided by the service itself. This scenario follows more the atom implementation of the download service (use of describedby for each "block") while still providing explicitly a get service metadata operation.

The reference to the spatial data service metadata is provided through the "MetadataUrl" element in the INSPIRE Extended Capabilities.

The operation section contains the GetCapabilities operation itself and an operation called "DescribeServiceOperations". This operation is a link to a document (for example a WSDL) that provides all the information needed to invoke the service.

An encoding example of this scenario is provided in Annex A.

4.5.3.3 Scenario 2 – Get Capabilities response – Metadata replication

In this scenario, all the metadata provided in the ISO metadata shall be repeated in the capabilities document (including INSPIRE Extended Capabilities metadata elements). This scenario is based on the experience of the discovery, view and downloads (WFS option) technical guidance.

NOTE In order to provide all the new metadata needed by the INSPIRE Spatial Data Service, the current XSD describing the INSPIRE Extended Capabilities would need to be extended. An example for the XSD's extension is provided in Annex A.

In addition to the service information metadata, an operation for each service's operation has to be provided in the operation metadata section of the Get Capabilities response.

An encoding example of this scenario is provided in Annex A.
